- 1) In accordance with the 6th article of Eskişehir Osmangazi University Foreign Student Application, Admission and Registration Instruction International students who will newly register at Eskişehir Osmangazi University pay the determined semester tuition fees in online registration. Candidates who do not pay the semester tuition fees during the online registration dates lose their registration rights. The tuition fees paid by the candidates who make false statements and who are found to mislead the administration with any action or transaction will not be refunded.
- 2) Students who do not have TÖMER C1 certificate are obliged to pay the tuition fees of the program they are enrolled in. The tuition fees paid by students who do not have a TÖMER certificate of achievement are deducted from the following semester fees.
- 3) Within the scope of the quotas for student admission from abroad, international students who will be newly registered in the 2025-2026 academic year and are liable to pay fees, and international students who are obliged to pay fees, who are registered at Eskişehir Osmangazi University in the 2020-2021 academic year and after, pay the tuition fees indicated in Table 1.
- 4) International students enrolled in the daytime education programs of Eskişehir Osmangazi University in the 2018-2019 academic year and before, must pay 4 times of the amount of student contribution determined in the "Cumhurbaşkanlığı Yükseköğretim Kurumlarında Cari Hizmet Maliyetlerine Öğrenci Katkısı Olarak Alınacak Katkı Payları ve Öğrenim Ücretlerinin Tespitine Dair Karar". International students enrolled in the evening education programs must pay 1.5 times of the tuition fees for the evening education.
- 5) International students who are registered at Eskişehir Osmangazi University in the 2019-2020 academic year and who are obliged, pay the amounts determined by the University Administrative Board in the 2025-2026 academic year and the following years, with the Consumer Price Index increased annually in June of each year. However, the tuition fees cannot be higher than the fee paid by the students who registered for the first time in the relevant year.
- 6) a) Determined by Republic of Türkiye Presidency for Turks Abroad And Related Cummunities; The students who are graduated from the foreign high shool education institutions, which are affiliated to Ministry of National Education, Türkiye Diyanet Foundation and the Turkish Maarif Foundation, who are graduated from the international imam-hatip high schools that provide education within the scope of international imam-hatip student programs carried out in cooperation with the Türkiye Diyanet Foundation and the Ministry of National Education and minority high schools with affiliated Muslim religious administrations, educational institutions with the status of Imam-Hatip High School and who will be newly

enrolled in the daytime education programs of Eskişehir Osmangazi University within the scope of the quotas for student admission from abroad and the students who are still registered and who are still in the program period do not pay the tuition fees in accordance with the 5th and 6th paragraphs of the 3rd article of the Presidential Decision on the Determination of Tuition Fees, which is numbered 32249 and dated 15 July 2023, on which is about 'Eğitim-Öğretim Yılında Yükseköğretim Kurumlarında Cari Hizmet Maliyetlerine Öğrenci Katkısı Olarak Alınacak Katkı Payları ve Öğrenim Ücretlerinin Tespitine Dair'. decision statement. The tuition fees of these students are covered from the budget of Republic of Türkiye Presidency for Turks Abroad And Related Cummunities. Students who are within this scope and exceed the duration of the program pay the tuition fee determined by the University Administrative Board every year, as much as the international students who are obliged to pay tuition fees according to their registration status in the entry year. The provisions of this article are also applied for the students who entered this status in the 2025-2026 academic year and previous years.

- b) Blue card students enrolled in the daytime education programs of our university in the 2020-2021 academic year and before, students who completed their entire high school education abroad through formal education and whose one of nationality is the Republic of Turkiye, and Syrian nationals who were hosted in our country due to the events in the Syrian Arab Republic during application and registration students' don't pay tuition fees according to the second and third paragraphs of the temporary article of the Presidential Decision dated 15 July 2023 and numbered 32249 "2023-2024 Eğitim-Öğretim Yılında Yükseköğretim Kurumlarında Cari Hizmet Maliyetlerine Öğrenci Katkısı Olarak Alınacak Katkı Payları ve Öğrenim Ücretlerinin Tespitine Dair". The tuition fees of these students are covered from the budget of Republic of Türkiye Presidency for Turks Abroad And Related Cummunities. Students who are within this scope and exceed the duration of the program pay the tuition fee determined by the University Administrative Board every year, as much as the international students who are obliged to pay tuition fees according to their registration status in the entry year. The provisions of this article are also applied for the students who entered this status in the 2025-2026 academic year and previous years.
- 7) Students of Syrian nationals excluding those hosted in our country due to the events in the Syrian Arab Republic before the 2020-2021 academic year and the application and registration process in previous years pay the fee determined for the 2025-2026 academic year according to the University Administrative Board's decisions. As for following years they pay the redetermined fees every year for the students who come within the scope of the International Student Admission Quotas by University Administrative Board.
- 8) Students placed in associate and undergraduate programs of the university in accordance with the principles determined by the Council of Higher Education from countries with which the Council of Higher Education has signed a cooperation protocol and/or memorandum of understanding are subject to the 4th paragraph of the 3rd article of the Presidential Decision taht is on "2023-2024 Eğitim-Öğretim Yılında Yükseköğretim Kurumlarında Cari Hizmet Maliyetlerine Öğrenci Katkısı Olarak Alınacak Katkı Payları ve Öğrenim Ücretlerinin Tespitine Dair" and numbered 32249 dated 15 July 2023. and lose their placement conditions pay the tuition fees determined by the University Administrative Board every year, as much as international students who are obliged to pay tuition fees according to their registration status in the entry year. The provisions of this article are also applied for the students who entered this status in the 2025-2026 academic year and previous years.

- 9) International students who enroll in Eskişehir Osmangazi University with the quotas for student admission from abroad continue to pay the tuition fees determined by the University Administrative Board every year according to their registration status in the year of entry.
- 10) International students who enroll at our university with foreign student admission quotas and whose families and themselves have obtained residence permits in Turkey are eligible for a 25% sibling discount on the tuition fees set for these students if they can prove that more than one student from the same family is actively pursuing associate's or bachelor's degree programs at state higher education institutions.
