ESKİŞEHİR OSMANGAZİ UNIVERSITY
INTERNATIONAL STUDENT ADMISSION PLACEMENT PRINCIPLES

- 1) The applications of international student candidates who apply within the framework of “Eskişehir Osmangazi University International Student Application, Admission and Registration Directive” are admitted through the online preference management system made available during the application period announced on the website of the International Student Admission and Registration Coordinatorship (<https://student.ogu.edu.tr>, <https://student.ogu.edu.tr/en>).
- 2) Applications for the actual placement are made with the scores of the exam types specified in Table 1. In order to be placed in a department/program, the candidate must meet the base score requirement from the exam types specified in Table 1. Those who are eligible to be placed in our university among the applicants who apply with SAT exam must verify their score by entering the SAT exam system under the control of the coordinatorship officer during the submission of the registration documents. Those who cannot verify their test scores for any reason will not be enrolled in our university, their registration rights will be canceled and the fee(s) they have paid will not be refunded.
- 3) Provided that they have applied during the main placement period, a substitute list for the main placement is created up to 50% of the program quota applied for. In the formation of the original placement reserve list;
 - a) Among the candidates who have not been placed in any department/program in the current applications, according to the score superiority specified in Table 1,
 - b) Without prejudice to the provision of Article 15, the number of candidates from the same country who are entitled to reserve registration does not exceed 40% of the total reserve quota of the relevant program,Depending on the placement, it is created in the preference management system and announced in ranked order through the system. After the completion of the acceptance letter procedures of those who have the right to enroll as a result of the primary placement, the candidates are given two working days to pay the first semester fee of the program for which they are the substitute by sending an e-mail to the candidates according to the ranking in the original placement reserve list. Candidates who pay the first semester fee within this period are issued an acceptance letter and are given the right to enroll in the program.
- 4) Applications for vacancies other than primary placement;
 - a) The score of the exam types specified in Table 1,
 - b) The university entrance exam score/exam score of the country where the candidate graduated from secondary education as indicated in Table 3,
 - c) Secondary school graduation exam / high school graduation exam score of the country where the candidate graduated from secondary education,
 - d) Secondary education (high school) diploma grade / graduation grade point average of the candidate,is done accordingly.

- 5) In the evaluation of vacant quota applications other than the actual placement, placement is made by the preference management system by taking into account one of the scores specified in subparagraphs a, b, c of Article 3. In the evaluation of vacant quota applications, if the department/program quota is not filled as a result of placement according to subparagraphs a, b, c of Article 3, placement is made by the preference management system according to subparagraph d in the same quota period.
- 6) Provided that they have applied during the vacant quota period other than the main placement, a reserve list of 50% of the program quota applied for is created. In the creation of the reserve list for vacant quota placement;
 - a) Among the candidates who have not been placed in any department/program in the current applications, based on the score superiority specified in Article 4 and Article 5,
 - b) Without prejudice to the provision of Article 15, the number of candidates from the same country who are entitled to reserve registration for the vacant quota does not exceed 40% of the total reserve quota of the relevant program,

Depending on the program, it is created in the preference management system and announced in ranked order through the system. After the completion of the acceptance letter procedures of those who have the right to enroll as a result of the vacant quota other than the main placement, the candidates are given two working days to pay the first semester fee of the program they are substituting by sending an e-mail to the candidates according to the ranking in the vacant quota placement reserve list. Candidates who pay the first semester fee within this period are issued an acceptance letter and are given the right to enroll in the program.

- 7) In all application periods, candidates must meet the base score requirement from the National Diploma/High School Graduation Exams specified in Table 2.
- 8) International student candidates can apply to a maximum of 10 departments/programs and will be placed in only one department/program. The international student placed in a department/program will not be horizontally transferred to another program.
- 9) The scores of candidates who meet the application requirements and fulfill the placement conditions are converted to a percentile scale, with a maximum score of 100, and ranked accordingly.
- 10) In case of equality in the exam score of the candidates in the original placement and in the main placement reserve list, first priority is given to the one with the higher secondary education (high school) diploma grade, and if the equality continues, the younger age is given priority. In case of age equality, the candidate's preference ranking is considered. If the equality continues, the one with the most recent secondary education (high school) graduation year is given priority.
- 11) In case of equality of the exam results of the candidates specified in subparagraphs a, b and c of Article 3 in the applications for vacant quotas other than the primary placement and in the reserve list of vacant quotas; the one with the higher secondary education (high school) diploma grade is given priority first. In case of equality, the younger age is given priority. In case of age equality,

the candidate's preference ranking is considered. If the equality continues, the one with the most recent secondary education (high school) graduation year is given priority.

- 12) In case of equality of higher secondary education (high school) diploma grade of the candidates specified in subparagraph d of Article 3 in the applications for vacant quotas other than the actual placement; at first the younger age is given priority. In case of age equality, the candidate's preference ranking is considered. If the equality continues, the one with the most recent secondary education (high school) graduation year is given priority.
- 13) In the placements to be made for each of the vacant quota period(s) to be opened after the actual placement and the actual placement, the number of candidates who are entitled to enroll from the same country cannot exceed 40% of the total quota of the relevant program in each period. In each of the reserve lists to be formed according to Article 3 and Article 6 during the placement periods, the number of candidates from the same country who are entitled to enroll cannot exceed 40% of the reserve list quota. In case the quotas are not filled, candidates are placed in the unfilled quotas according to the placement score order without taking this rule into consideration to be applied in the list of candidates eligible for placement created in the preference management system for the relevant application period and reserve lists. Article 15 is reserved for first education (daytime) programs. For placements in second education programs, the country quota restriction does not apply.
- 14) The University Senate has the authority to impose restrictions on admissions of international students based on nationality for the specified academic year.
- 15) According to Article A, Paragraph 2, Subsection (c) of the Principles Regarding the Admission of International Students by the Council of Higher Education Presidency, a 10% quota restriction is applied to the faculties of Medicine, Dentistry, Law, and Education for candidates who have the opportunity to apply for admission quotas from abroad, candidates who were Turkish citizens by birth according to the Turkish Citizenship Law but have lost their Turkish citizenship by obtaining permission from the Ministry of Interior Affairs to renounce their Turkish citizenship, candidates who can provide evidence of holding a blue card, candidates who are Turkish citizens and have completed their secondary education (high school) in a foreign country (except the Turkish Republic of Northern Cyprus (KKTC)), and have dual citizenship with one of them being Turkish citizenship. In the main placement, if the aforementioned 10% quota is filled, those who are not registered or those who are within the scope of this limitation cannot be placed in the additional placements to be made to the vacant quotas.
- 16) Document control of the candidates who applied during the main placement and vacant quota periods other than the main placement via the preference management system is carried out by the International Student Admission and Registration Coordinator or the member(s) of the International Student Admission and Registration Commission. As a result of the preliminary examination of online applications, the applications of candidates who are found not to meet the application and placement requirements are not evaluated.

- 17) If an international student applicant fails to pay the first semester tuition fees and complete the online registration within the specified dates of the application period, they will forfeit their right to registration.
- 18) The applications of candidates who make false statements, who are found to mislead the administration with any action or process are rejected. If the online / final registrations of these candidates have been made, they are canceled and dismissed from the university. The semester fee(s) they have paid will not be refunded.
- 19) Acceptance letters regarding the department/program in which international student candidates are placed are signed by the International Student Admissions and Registration Coordinator and submitted through the online preference management system after the candidate pays the semester fee of the program he/she has won.
- 20) The acceptance letters of international student candidates for the department/program in which they are placed are opened on the date specified in the calendar on the webpage of the International Student Admissions and Registration Coordinatorship, and the acceptance letters are closed to the access of the candidates at the end of the online registration date of the relevant semester.
- 21) Students who wish to apply for programs that admit students through special talent exams are required to participate in the talent exams conducted by the Faculty of Arts and Design.
- 22) Students who register online must submit the documents required for final registration to the International Student Admissions and Registration Coordinatorship of the University within the dates specified on the website of the International Student Admissions and Registration Coordinatorship of the University (<https://student.ogu.edu.tr>, <https://student.ogu.edu.tr/en>) in person or by persons to whom they will give notarized power of attorney to the International Student Admissions and Registration Coordinatorship of the University (Those who will register with a power of attorney must have the power of attorney obtained from their countries apostilled or approved by the Turkish Consulates). Registration by mail is not accepted. Registration is not accepted with missing documents. The registration of the student who fails to submit his/her documents within the registration period will be deleted.
- 23) International students who are entitled to final registration are obliged to fulfill the conditions specified in the "Cooperation Protocol on Residence Permit Applications of International Students" signed between the Presidency of the Council of Higher Education and Republic of Türkiye Ministry of Interior Presidency of Migration Management on November 15, 2023 regarding visa and residence permit procedures.
